## **1 RULES**

The regatta will be governed by the rules as defined in The Racing Rules of Sailing 2009 – 2012.

## **2 ADVERTISING**

Boats may be required to display advertising chosen and supplied by the organizing authority.

## **3 ELIGIBILITY AND ENTRY**

**3.1** The regatta is open to all boats. Two classes of Portsmouth and Dagger Board

**3.2** Five entries of the same make and model will be a class.

**3.3** Eligible boats may enter by completing the attached form and sending it, together with the required fee, by March 14<sup>th</sup> to

## **4 FEES**

**4.1** Required fees are as follows:

- All classes \$35.00
- Junior Skippers (16 year of age and under) \$20.00

**4.2** Fee includes skipper's dinner and one T- Shirt.

**4.3** Other fees:

- \$5.00 discount off of the registration fee for US Sailing or CCYC memberships.
- \$5.00 fee for each crew or family member's dinner.
- Early paid registers receive five free raffle tickets.

## **5 SCHEDULE**

**5.1** Registration:

Friday at 3 Bananas from 6pm till 8pm.

Saturday, March 27, 2010 at 3 Bananas from 9am till 10am.

**5.2** Dates of Racing:

**5.3** Number of races scheduled: 5 races.

## **6 VENUE**

The regatta will be held on Lake Crescent in Crescent City, Florida.

## **7 SAILING INSTRUCTIONS**

The sailing instructions will be available after 1800 on March 26, 2010

## **8 COURSES**

8.1 Courses will be contained in the sailing instructions. Courses will be windward-leeward and / or triangle courses with drop marks.

## **9 SCORING**

One race is required to be completed to constitute a series.

## **10 SUPPORT BOATS**

Support Boats will be marked with a CCYC flag.

## **11 BERTHING**

**11.1** Slips are available at 3 Bananas

**11.2** Contact 3 Bananas at (386)698-2861 for information on slips.

**11.3** Launching and set up can be done at two areas; on Central Avenue and the Margery Neal Sunshine Park by the Crescent City Water Tower

## **12 RADIO COMMUNICATION**

Except in an emergency, a boat shall neither make radio transmission while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

## **13 PRIZES**

Trophies will be awarded for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place finishers of their class.

Competitors participate in the regatta entirely at their own risk. See rule 4. Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.
